#### **Purpose:**

EFA's event at the European Parliament in June 2014 "How does innovative research for respiratory diseases in the EU involve patients? The examples of AirPROM, EARIP, MeDALL and U-BIOPRED" will present four ongoing EU funded projects where patients are actively participating and should stand to benefit from their outputs. The project coordinators from each of these EU projects will have an opportunity to present the ongoing work in their projects and explain how patients have played a meaningful role. Panel discussions will inquire further into describing ways in which European patients, research initiatives and the EU as a whole all stand to benefit from such projects. These benefits will be assessed from the perspectives of the project coordinators, patient representatives and policymakers.

#### Aims:

The programme above outlines one example of an approach which can aim towards:

- 1. Educating the public and policymakers on a diverse range of the different EU projects focused on respiratory diseases along with their goals and anticipated outcomes (or actual results if there are any at that time)
- 2. Demonstrate the utility of EU-funded research projects for patients and how integrating patients into the projects is beneficial
- 3. Informing relevant stakeholders in attendance of ways project outcomes could assist European healthcare systems and improve patients' quality of life in the future

#### **Outcomes:**

- 1. Establish a precedent for future events for each of the EU projects involved
- 2. Attraction of interest from diverse groups of stakeholders and increase awareness of the projects among policymakers at the European institutions
- 3. Clear demonstration of how patient involvement in research is beneficial and how EU funded projects serve the interests of patients and healthcare systems
